

EASTERN PROMISE: CHRISTIE'S LONDON ASIAN ART SALES IN MAY

London – Following the strong results of Christie's New York Spring 2007 Asian Art sales, the world's leading art business is pleased to announce the London sales of Asian Art in May 2007. The sales herald the return of Modern and Contemporary Indian Art sales to London and for the first time, offer clients around the world the opportunity to bid online in real-time via Christie's LIVETM in the King Street sales of Indian, Chinese and Japanese works of art.

Fine Chinese Ceramics and Works of Art, Including Export Art: 15 May 2007 at 10.30am & 2.00pm – Bid via Christie's LIVETM



Ushering in Christie's London Asian art sales in May, the sale of *Fine Chinese Ceramics and Works of Art* on 15 May will offer over 430 lots including superb sculptures, bronzes, ceramics, furniture and paintings which are estimated to fetch in excess of £4 million. Amongst the exquisite selection of ceramics are two rare blue and white porcelain pieces decorated with Imperial dragons. The first is a vibrantly painted stem bowl dating to the Xuande reign (A.D. 1426-35) (estimate: £150,000-200,000), and the second is a *Nine Dragon* vase from the Qianlong period (1736–95) (estimate: £100,000–150,000) (illustrated left), which may have been made to celebrate an Imperial birthday. Made for the Iberian market, is a rare late Ming blue and white armorial flask, which may have been

ordered by a knight either of the Order of Aviz or the Order of Christ during the Spanish occupation of Portugal in *circa* 1610-20 (estimate: £180,000-220,000).

Another exceptional piece is an exquisitely carved and painted Imperial ivory figure of a seated Asian lady in Western dress from the Qianlong period (1736-95) (estimate: £150,000-200,000), which appears to have been based upon a portrait painted by one of the European Jesuit missionaries at the Chinese court. Also from the Qianlong reign is a very rare aloeswood *Seven-Buddha* bowl inscribed with the year 1786 (estimate: £120,000-180,000), which was in the de Jonge Family Collection for over a century and is the only known example of this type made from aloeswood. A rare early Ming gilt-bronze figure of the Buddha Maitreya, from the Yongle reign (1403-



1425) is a superb example of the exceptionally fine Tibeto-Chinese sculptures made in the late Yuan and early Ming dynasties under the influence of Lamaist Buddhism (estimate: £100,000-150,000) (illustrated above right).

A private collection of timelessly elegant Chinese furniture, predominately from the 17^{th} and 18^{th} centuries, which is surprisingly contemporary in the simplicity of its lines, is also included in the sale (estimates range from £1,500-20,000).

Japanese Art and Design and The François Stormo Collection of Netsuke: 16 May 2007 at 10.30am & 2.00pm – Bid via Christie's LIVETM



Hidden away in a private collection for over fifty years is a rare and important five-coloured Ko-Kutani porcelain from the Edo period (estimate: £200,000-300,000) (pictured left) which leads Christie's Japanese Art and Design sale on 16 May 2007. Depicting a Chinese scholar offering tea to his guest, the nine-lobed dish was last exhibited publicly in the 1950s and is amongst 450 lots of lacquer, netsuke, ceramics, swords and Meiji period (1868-1912) works of art to be offered in the sale.

Further sale highlights include two elegant Kakiemon figures of ladies in colourful kimonos which

have only recently been discovered in an English country house (estimates: £80,000-100,000 & £70,000-90,000 respectively) and *The François Stormo Collection of Netsuke* from Switzerland of over 160 lots which is estimated to fetch in excess of £500,000. The lacquer market continues to be strong and a number of superb examples from the 16th century through to the 20th century will be offered including a 20th century paper storage box depicting grasses, with a vibrant red lacquer interior (estimate: £8,000-10,000) (*illustrated right*). The sale concludes with an impressive group of 50 swords including some certificated



Juyo, combining the private collection from Europe and further swords from Japan and America; estimates range from f, 1,500 to f, 80,000.

Chinese Ceramics and Works of Art at Christie's South Kensington: Friday, 18 May 2007 at 12 noon – Bid via Christie's LIVETM



A decorative selection of Chinese ceramics and works of art alongside classical and contemporary paintings will be offered in this sale with estimates ranging from £500 to £25,000. Highlights include a pair of 'Palace workshop' lacquer display cabinets, Qianlong (1736-95) (estimate £10,000-15,000); a selection of fine jade carvings including a rare pale celadon jade two handled octagonal cup, Ming Dynasty (1368-1644) (from the Collection of the Yijin studio) (estimate: £10,000-15,000); and a gold

perfumer flattened heart-shaped box and cover decorated in open-work repousse, Ming dynasty (1368-1644) (estimate: £3,000-5,000) (illustrated above left).



Modern & Contemporary Indian Art including Art from Pakistan and Sri Lanka: 21 May 2007 at 2.00pm – Bid via Christie's LIVETM (separate press release available)

In 2006, Christie's marked an exceptional year in the contemporary art market, with Modern and Contemporary Indian art becoming one of the art market's fastest growing areas. As market leader in the field, Christie's is pleased to announce the return of *Modern & Contemporary Indian Art* sales to London on 21 May 2007. Christie's LIVETM has recently been introduced in Paris in April, and in May 2007 will be available in both Geneva and Hong Kong.
