# THE CHÂTEAU DE GOURDON COLLECTION REALISES €42 MILLION / £37 MILLION / \$59.3 MILLION

# 13 WORLD RECORDS FOR ARTISTS AT AUCTION

# 8 WORKS SOLD FOR OVER €1 MILLION/8 OVER £1 MILLION/ 9 OVER \$1 MILLION

# **BUYERS FROM 30 COUNTRIES COMPETED IN 5 SALES OVER 3 DAYS**

**Paris** – Having captured the attention of international collectors around the world, Christie's landmark series of five sales over three days from *The Château de Gourdon Collection* at the Palais de Tokyo, Paris, realised a total of €42,387,113/£37,065,000/\$59,346,000 selling 84% by lot, and 84% by value.

One of the finest private collections of early 20<sup>th</sup> Century Decorative Art and Design ever to be offered at auction, The Château de Gourdon Collection comprised important one-off pieces, prototypes, special commissions and objects created by some of the artists for their own use. The spectacular public exhibition curated by Nathalie Crinière at the Palais de Tokyo drew the admiration of over 17,000 visitors in 4 days. Buyers (by lot / by origin) were 75% European, 21% American, 2% Asian and 1% Middle-Eastern, they bid competitively on the telephone, in the room and on Christie's Live<sup>TM</sup> throughout the five sales.

8 works of art sold for over €1 million (8 over £1 million and 9 over \$1 million). 13 world records were set for artists at auction, led by the chaise longue by **Emile-Jacques Ruhlmann** (lot 18) at €2,865,000 /£2,528,362 /\$4,048,245.

"A resoundingly strong result for this spectacular collection. Big prices were achieved in the opening session, setting the tone for the week, with eight lots fetching in excess of €1million. Competitive bidding remained consistently strong throughout the subsequent two days of sales. The work of French Modernists under the collective banner of the UAM (Union des Artistes Modernes) have never before been presented so comprehensively; this exceptional spotlight served the artists well and great results were achieved for Robert Mallet Stevens, René Herbst, the Martel brothers, Eileen Gray and other leading lights of this pioneering group. Christie's are privileged to have been entrusted with the sale of this collection. It involved a highly complex

operation, staged in the monumental Parisian venue of the Palais de Tokyo. The pre-sale exhibition drew 17,000 people over four days. The sale of the Château de Gourdon Collection will be remembered as a historic event for the French auction market and for 20<sup>th</sup> century Decorative Art and Design."

"It was an exceptional sale. The international market responded with enthusiasm to this superb ensemble, particularly the Art Déco and UAM works. We are proud to have fetched 13 world auctions records for artists from this period; Christie's remain the international leader in this specialist field." # **ART DÉCO**

The impressive collection included 35 examples by **Emile-Jacques Ruhlmann (1879-1933)**, which realised more than  $\\mathbb{e}13$  million/£11million /\$18 million. Considered the 'Riesener' of the 20<sup>th</sup> century, he is hailed as the master cabinet-maker and 'ensemblier' of this period. International private collectors and art dealers were seduced by fine pieces in Macassar ebony, rosewood and mahogany, with inlays of ivory, tortoiseshell and shagreen. Having been declared a Trésor National\*, the star lot of the sale was Ruhlmann's chaise longue 'on skis' (lot 18), 1929, which sold for  $\\mathbb{e}2,865,000$  / £2,528,363 / \$4,048,245, setting a world auction record for the artist.

The 'Tardieu' writing desk (lot 14), sparked competitive bidding and sold to Vallois Gallery for  $\[ \in \] 2,305,000 \] / \[ \le \] 2,034,162 \] / \[ \le \] 3,256,965,$  the second highest price for Emile-Jacques Ruhlmann at auction.

Bidders also competed fiercely for Ruhlmann's imposing 'Lassalle' commode, *circa* 1925, (lot 71) which sold for €1,801,000 /£1,589,383 /\$2,544,813; the 'Nicolle' drinks cabinet (lot 66) of 1926 which fetched €1,498,600 /£1,322,514 /\$2,117,522 and the 'Colonnettes' dressing table (lot 69), *circa* 1919-1920, which realised €337,000/£297,403/\$476,181.

The visionary designs of **Eileen Gray** captivated the imagination of many during the public viewings at the Palais de Tokyo. Gray's black-lacquered 'Brick' screen (lot 26), which was developed from the panels she used in the hallway of the apartment of Suzanne Talbot on Rue de Lota, *circa* 1922, sold for €1,353,000/£1,194,022/\$1,911,789. This was part of her personal furnishings and featured in her apartment on Rue Bonaparte. The 'Bibendum' armchair (lot 31), with a tubular chrome base and seat formed from stacked, curved, cream-coloured 'sausages', which clearly evoke the logo of tire-manufacturer Michelin, was sold for €709,000 /£625,692 /\$1,001,817.

The *Les Palmiers* paneling by **Jean Dunand** (lot 25), comprising panels of incised, textured and lacquered wood, commissioned *circa* 1928-1929 for the smoking room of a Paris apartment, was also was declared a Trésor National\* and sold for €2,193,000 /£1,935,322 /\$3,098,709.

The section for perfume bottles (lots 446 to 475) sparked competitive bidding in the room and on the telephone, realising a combined total of  $\leq 164,785/$  £145,423/  $\leq 232,841$ . Baccarat

bottles, such as the Baccarat perfume bottle for Guerlain (lot 464) which realised  $\leq 7,500/$  £6,619 / \$10,598, fetched up to ten times their pre-sale estimates.

# **U A M (Union des Artistes Modernes)**

**Robert Mallet-Stevens (1886-1945)**, the UAM Chairman, was represented by more than 30 lots, with a number originating from his personal collection, notably his dining room. The four lots from the Villa Cavrois located in Croix, in northern France (lots 42 to 45) will return to their original home having been 'pre-empted' for €540,000/£476,550 /\$763,020 by **le Centre des Monuments Nationaux** for the Cavrois villa.

**Pierre Chareau (1883-1950)** highlights were led by the famous 'Religieuse SN31' (lot 395) with alabaster shades which sold for €589,000/ £519,793/ \$832,257, setting a world auction record for lighting by the artist. Five pieces of furniture designed for the child's bedroom at Maison de Verre were also 'pre-empted' by **le Musée des Arts Décoratifs** (lot 415 to 419).

The series of sales drew to a close with an auction purely featuring works by the UAM, it totalled €6.2 million/ £5,471,500/ \$ 8,760,600, selling 90% by lot and 90% by value. Impressive prices were achieved for works by René Herbst, Boris Lacroix, Jan & Joel Martel, Robert Mallet-Stevens, Pierre Chareau, Gérard Sandoz, Hélène Henry, Jean-Paul Sabatou, Jean Perzel, Jacques Adnet, among others.

A chair by **Eileen Gray**, *circa* 1926-1929 (lot 800), a circular gueridon, 1928 (lot 837) by **René Herbst** and a pivoting chair by **Louis Sognot and Charlotte Alix**, *circa* 1930 (lot 870) were 'pre-empted' by **Le Georges Pompidou Museum**.

Artist records were set for works by **Boris Lacroix** (lot 806); **René Coulon** (lot 65); the **Martel** brothers with the UAM woman, Nude, 1931 (lot 39) which realised €313,000/£276 223/ \$442,269 and the lighting of **René Herbst** (lot 844) and **Jacques Adnet** (lot 32), which realised €133,000/£117,373/ \$187,929 and €139,000/£122,668/\$196,407 respectively.

## **ART NOUVEAU**

The extravagant mahogany bed and its pair of bedside tables, produced *circa* 1905, sculpted in sensual fluid forms ornamented with gilt bronze water-lilies by **Louis Majorelle (1859-1926)** fetched a world auction record for the artist, selling for  $\[ \in \]$ 1,162,600/  $\[ \in \]$ 1,025,995/\$1,642,754. The matching desk far exceeded its pre-sale estimate selling for  $\[ \in \]$ 259,000/  $\[ \in \]$ 228,568/\$365,967. Two further artist records were set when a pair of candelabras by **Maurice Bouval (1822-1912)** (lot 351) realised  $\[ \in \]$ 75,400/  $\[ \in \]$ 66,541/  $\[ \in \]$ 106,540, and a table lamp by **Mathurin Moreau (1822-1912)** (lot 350) fetched  $\[ \in \]$ 61,000/  $\[ \in \]$ 53,833/ \$86,193.

#### **MODERNISM IN PRINT**

The sale of books, documents and photographs totalled €566,200/ £499,672/ \$800,041, selling 82% by lot and 91% by value. The Maharaja of Indor portraits by **Man Ray (1890-1976)** far exceeded their pre-sale estimates.

# OLD MASTER PAINTINGS, ARMS AND ARMOUR, SCULPTURE, FURNITURE AND WORKS OF ART

The three sections of this sale were all met with great enthusiasm, fetching in excess of €2 million/ £1.7 million / \$ 2.8 million. Highlights included a Louis XVI secrétaire by **René Dubois** which sold for €361,000/ £318,583 / \$510,093; the *Adoration of the Magi, the Nativity and The Circoncision* which realised €313,000/ £276,223 / \$442,269 against a pre-sale estimate of €60,000-80,000 and a wooden sculpture representing St. Sebastien, which fetched eight times its pre-estimate, selling for €91,000/ £80,308 /\$128,583. Among the Arms and Armour there was particularly strong demand for flintlocks and carbines.
