London- Christie's concluded *Islamic Art Week* with a combined total of £6,662,788 /\$9,984,212 /€9,284,939, achieved over three sales at London King Street and South Kensington, between 21 and 24 April 2015.

Department commented: "This season's sales of Islamic art achieved £,6,662,788, a solid increase on last season (£,5.7 million). The sales saw buyers from across the world bidding with determination for the very best examples. We were pleased to welcome interest and participation from new clients throughout the week. There was particularly strong demand for pieces with notable provenance, as demonstrated by the sale of works from a Private Swiss Collection sold at King Street. The price of £,422,500 realised for the Important Damascus-style' Iznik Pottery Dish, lot 175, is an auction record for its type. At Christie's South Kensington, the Private Collection of Andalusian manuscripts attracted fierce competition, realising £,346,000. The top lot of Islamic Art Week was the only known Mongol flatwoven carpet which made £,602,500. We look forward to the sale of Arts of India at King Street on 10 June."
