New York – Christie's New York online sale <u>Art of China | Including Property from the Junkunc Collection</u> (June 11-29) achieved a total of \$1,629,250 with 266% hammer above low estimate and 86% sold by lot. There was global participation with bidders from 15 countries across 5 continents.

The top lot of the sale was a Dehua Figure of a Guanyin from the 17th-18th century, which sold for \$187,500 after a marathon 61 bids. Additionally, strong results were achieved for jade carvings, gilt bronzes, porcelains and scholar's objects from the collection of Stephen Junkunc, III; Qing porcelains from an important private New York collection; and *huanghuali* furniture from a prominent estate.

Chinese paintings from the collection of the Lee Family of Chicago, Illinois, commanded impressive prices, as did paintings sold by the Yale University Art Gallery to benefit acquisition funds including Chen Qikuan (Chen Chi-Kwan, 1921-2007), *Where The Buffaloes Roam*, that sold for over five times its estimate realizing \$27,500.
