## Christie's Hong Kong Magnificent Jewels Spring Auction **Achieved HK\$439,698,540/ US\$56,277,104**

### An Exceptional Jadeite Bead Necklace

**Price Realised: HK\$69,037,500/ US\$8,836,123**

**Hong Kong** – On 25 May, Christie's Magnificent Jewels live auction totalled HK\$439,698,540/ US\$56,277,104 with solid sell-through rates of 85% by lot and 83% by value, and drew global participation from 13 countries across 4 continents.



The top lot of the sale, an **Exceptional Jadeite Bead Necklace**, sparked spirited competition and eventually sold for HK\$69,037,500/ US\$8,836,123 to a collector on the telephone.

**Vickie Sek, Chairman, Department of Jewellery, Christie's Asia Pacific**, commented, "Our Hong Kong saleroom exhibited market vibrancy and strong buying momentum, extended from our Geneva saleroom where we set an auction record for The Rock of 228.31 carats just earlier this month. We are delighted to have achieved strong prices across the diverse selection of fine jadeite, rare coloured and colourless diamonds, as well as important coloured gemstones. We are very well positioned to further engage collectors worldwide with our upcoming Magnificent Jewels auction including Twelve Jewels by JAR from The Estate of Ann Getty & the 103-carat D colour flawless Light of Africa Diamond, in New York on 8 June."
