# TREASURES FROM TWO COUNTRY HOUSES: ENCOMBE AND LA CHASSE TO BE SOLD AT CHRISTIE'S IN JANUARY 2007

## Property from Encombe, Dorset, and La Chasse, Jersey Christie's South Kensington 23 January 2007

London – The London House Sale department starts the New Year in grand style with the sale of the contents from two fascinating private country-house collections, Encombe in Dorset and La Chasse in Jersey, which are to be offered in one sale at Christie's South Kensington on 23 January 2007. Encombe was the family seat of the Earls of Eldon and many of the lots offered come with a fascinating history and provenance including memorabilia relating to John Scott, 1<sup>st</sup> Earl of Eldon, who was Lord Chancellor to both George III and George IV. While La Chasse in Jersey was home to the late Mrs Monica Black who created an elegant residence full of many remarkable works of art. This sale offers collectors and history-lovers alike the opportunity to acquire superb and individual items from two unique properties, with estimates ranging from £100 to £80,000.

Set in a secluded valley on the Dorset coast, Encombe was enjoyed by successive generations of the Scott family. The estate was acquired by John Scott, 1<sup>st</sup> Earl of Eldon

(1751-1838), Lord Chancellor in William Pitt the Elder's Government. A valued counsellor to both George III and George IV, he was closely involved in the latter's divorce proceedings against Caroline of Brunswick.

Following his retirement from the woolsack in 1827, Lord Eldon wrote to his wife of "the very great expense of the various improvements" undertaken at Encombe and a selection of pictures, furniture, sculpture and silver from this period are included in the sale. A bronze statue of George IV modelled as Caesar attributed to Rundell, Bridge and Rundell (estimate: £7,000-10,000) and labelled as being purchased by Lord Eldon after he retired from office, is a highlight. While a sumptuous velvet ceremonial Lord Chancellor's bourse (estimate: £3,000-5,000) is a vivid reminder of Lord Eldon's role in Government. The sale also includes portraits of the 1<sup>st</sup> Earl together with a wax bust of him by David Morison (estimate: £200-300).

A selection of paintings, watercolours and prints from the house are included in the sale. Among the family pictures is a charming group portrait of Eldon's three great grand-children, painted in 1839 by Henry Perronet Briggs, R.A. (estimate: £25,000-35,000). Here the children are gathered around the favourite family German spaniel called "Pincher", who was added to the portrait in the same year by Sir Edwin Landseer, R.A.. Further pictures offered include a striking portrait of the  $3^{rd}$  Earl of Eldon by George Richmond (estimate: £7,000-10,000) and a charming watercolour of a golden eagle in mid-flight by Josef Wolf (estimate: £1,000-1,500) along with an amusing collection of early  $19^{th}$  century political caricatures (estimate: £1,500-2,500).

Among the furniture highlights is a decorative suite of Etrusian furniture which includes a pair of demi-lune games tables (estimate: £4,000-6,000) and a set of twelve decorated dining chairs (estimate: £15,000-25,000), along with a magnificent oak banqueting hall sideboard (estimate: £2,000-3,000) given by the Eldon Estate tenants on the occasion of the 3<sup>rd</sup> Earl's marriage. A wide range of works of art are also offered together with a selection of ceramics and glass, including a Meissen model of an eagle,  $19^{th}$  century (estimate: £2,000-3,000) and a collection of black top hats (estimate: £150-250).

La Chasse was home to the late Mrs Monica Black, one of Jersey's most elegant residents. Her house contained a charming combination of old family furniture and pictures with lighter pieces acquired for the house. The undoubted star of her collection is an extremely rare 19<sup>th</sup> century Anglo-Indian ivory-veneered Davenport desk which is signed by Yendapilly Veraslingum, the Vizagapatam craftsman who made it, *circa* 1860-90 (estimate: £50,000-80,000). A further Vizigapatam ivory-veneered bureau on a Regency stand, late 18<sup>th</sup>/early 19<sup>th</sup> century (estimate: £6,000-9,000) is also offered.

Mrs Black's interest in  $18^{th}$  and early  $19^{th}$  century France is represented by an Empire *scagliola* and giltwood centre table attributed to Jacob (estimate: £15,000-25,000), as well as by an exciting selection of French decorative prints. Superb  $18^{th}$  century English furniture also features in the collection including a George II mahogany side table, *circa* 1750 (estimate: £40,000-60,000), a George II giltwood mirror, *circa* 1755 (estimate: £12,000-18,000), together with an Irish George II gilt gesso and giltwood console table, *circa* 1750 (estimate: £10,000-15,000).

The Black collection also boasts an atmospheric painting by George Elgar Hicks entitled Waiting for the Boats, 1864 (estimate: £30,000-50,000) and a charming pair of mid-18<sup>th</sup> century Chinese export reverse-painted mirror pictures (estimate: £6,000-9,000). Additional works of art include a pair of Paris porcelain cylindrical cache-pots, 19<sup>th</sup> century (estimate: £500-800) and a collection of silver-mounted, mother-of-pearl shell dishes (estimate: £300-500).
