The auction will include a selection of 34 works donated to the Americas Society that will be offered in conjunction with the Christie's **Latin American Evening and Day** sales. The sale features artists who have exhibited at the Americas Society throughout its stellar history and making their first appearance at auction. All proceeds from the sale will benefit the creation of an endowment for the Society's Visual Arts program.

Works by three exceptional artists will be among the highlights of the evening session – **Diego Rivera's** *Returning from the Market* (pictured above; center); **Carlos Cruz-Diez's** *Physichromie No. 1601* (pictured above; left), and **Jesús Rafael Soto's** *Petit carré rouge* (pictured above; right).

Diego Rivera's *Returning from the Market*, was donated by noted philanthropist, collector, and Americas Society founder, David Rockefeller (estimate: \$60,000-80,000). This watercolor represents a scene from Chalchicomula where a man carries home a heavy load at the end of the workday. The enormous rolled-up mat, bundle, and diagonals that compress and enclose the figure dramatize the subject's oppressed condition.

Carlos Cruz-Diez's *Physichromie No. 1601* was donated by the Aterlier Cruz-Diez in Paris (estimate: \$60,000-80,000). The artist has said: "Color is a situation which evolves..." The dazzling display of the vitality of color in *Physichromie* offers the viewer a sensual and cerebral experience, and exemplifies how Cruz-Diez employs line and color to create an optical illusion that challenges the viewer.

Jesús Rafael Soto's *Petit carré rouge* was donated by Patricia Phelps de Cisneros, one of the Chairs of this benefit auction (estimate: \$200,000-300,000). Born in Ciudad Bolivar in 1923, the Venezuelan artist Jesús Rafael Soto settled in Paris in 1950 and immediately became immersed in the study of pure non-figurative art as seen through the work of such modern masters as Mondrian and Malevich. Today Soto is considered one of the leading exponents of geometric abstraction, kinetic, and op art.
