London – Christie's announces the sale of **Alexandra Tolstoy: An Interior by Sibyl Colefax & John Fowler** online from 4 – 25 November. To view the sale please click <u>here</u>

The collection comprises approximately 130 lots from Alexandra's former London townhouse in Chelsea, London where she lived for eleven years. Alexandra worked closely with the London-based interior designers and decorators Emma Burns and Daniel Slowik of Sibyl Colefax & John Fowler Interiors from 2008 onwards to create her family home. The property in historic Chelsea was an inspired choice; comprising two



former artists' studios with high ceilings and large windows, it previously housed the modern British artists Walter Sickert and Sir William Rothenstein. Alexandra recognised the space as a blank canvas to create a welcoming and warm family home in the heart of London. Alexandra's inimitable eye for design and eclecticism, combined with Emma's expertise and aesthetic, ensured a stylish and

comfortable interior. Alexandra had previously collaborated with Emma on the design of her home in Moscow.

The interior and collection created

by Alexandra since 2009, speaks not only of her love of the traditional English country house, but also of her Russian family heritage, innate personal sense of style and a strong desire to create a special home for her children.

The objects and works of art offered at Christie's are all highly decorative and desirable. In most cases these pieces would work both in a townhouse



well as in the country, which is something that Alexandra finds as so appealing. From a large group of botanical prints to the selection of lamps and the japanned furniture supplied by Sibyl Colefax & John Fowler, the pieces are versatile and would meld into an existing interior scheme individually or as a group. It was in the more unusual and original pieces that Alexandra found most pleasure; the group of collage works by George Smart, (illustrated below left and far right), (estimate £3,000-5,000 and estimate £3,000-5,000), and the model of the Monastery of St Sergii, (illustrated below centre), (estimate £3,000-5,000), which Daniel Slowik imaginatively magnetised for display, being amongst her most treasured.
